



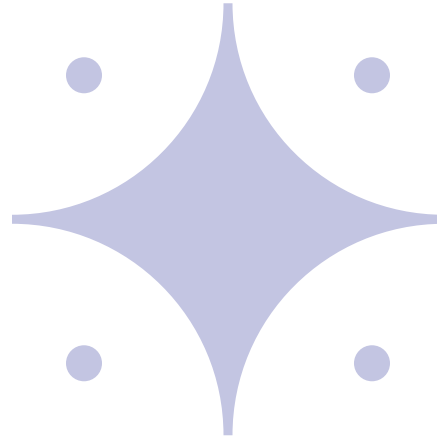

Once there was a dream. A dream of providing significant funds to charitable initiatives in the Owensboro area – initiatives that would improve lives throughout the community. This dream was not a small scale dream – this dream was bigger than life-size! The dream was to give a grant of at least \$100,000 each year. There are few individuals who have the means within their lifetime to give so much, but we believed there were many who would wish to be a part of such a gift.

How did this gift become reality? It was shared. It was shared with hundreds of women in Owensboro, and Impact 100 was born. The vision became reality when 150 women joined in 2006; when 208 women joined in 2007; when 256 joined in 2008. In just three years Impact has funded five grants totaling \$614,000.

The dream rejuvenates each year as more women share in the enthusiasm for the dream. Women join Impact and pool their \$1,000 gifts. Forming five focus area committees, they read proposals from non-profits seeking funding. They learn about the wonderfully inventive programs being designed to meet the needs of our community. And then, at our annual meeting, our members choose the program(s) to receive funding. Their shared enthusiasm makes the dream a reality year after year.

With our annual report, we share our success stories. We thank those who believe in our dream and help us reach our goals. And we invite others to join with us in fulfilling our dream... and the dreams of those who lives are touched daily by Impact's gifts to the community.

GRANDMA'S CORNER ~ \$150,000 Awarded

Mission: Grandma's Corner Crisis Prevention Center is a licensed non-profit childcare facility that provides a friendly, non-threatening environment for children whose parents are experiencing a stressful circumstance.

Program/Project: STARS Quality Safety and Health Improvements Project which included exterior playground safety renovations and expansion, interior health and safety improvements plus endowment funding to sustain and maintain quality improvements in the future.

2007 Grant Recipients

BOULWARE CENTER MISSION, INC. ~ \$104,000 Awarded

Mission: To alleviate homelessness, one life at a time, through education and services. The vision is to be a leading residential rehabilitation mission for displaced individuals and families focusing on recovery from those issues that brought about homelessness.

Program/Project: Expansion Project that reconstructed and renovated the new facility's main kitchen as well as remodeling the main dining area. Boulware Mission serves the homeless population of the Owensboro/Daviess County area by providing shelter, advocacy and services for the homeless men, women and children.

GIRLS INC. OF OWENSBORO-DAVISS COUNTY ~ \$104,000 Awarded

Mission: To inspire all girls to be strong, smart and bold.

Program/Project: Capital Improvement Project that established a

website, replaced and/or upgraded existing computers, furnishings, appliances, security systems and program supplies at the Rolling Heights Campus. Girls Inc. provides education programs to high risk girls in underserved areas in order to prepare them to lead successful, independent and fulfilling lives.

2008 Grant Recipient

HABITAT FOR HUMANITY ~ \$128,000 Awarded

Mission: Habitat for Humanity works in partnership with God and people everywhere, from all walks of life, to develop communities with people in need by building and renovating houses so that there are decent houses in decent communities in which every person can experience God's love and can live and grow into all that God intends.

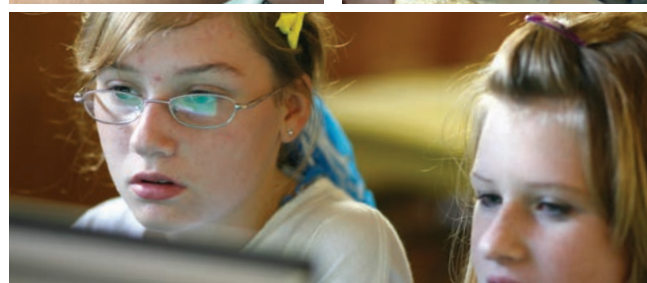
Program/Project: "A Home for Habitat" Project established a permanent presence in the community by purchasing a known facility with office and warehouse space combined. Habitat for Humanity builds good, decent, affordable homes for very low-income families and now has a home of its own.

Mission: The Owensboro Area Shelter and Information Services, Inc., (O.A.S.I.S.) is committed to provide shelter, support, and advocacy to families affected by domestic violence.

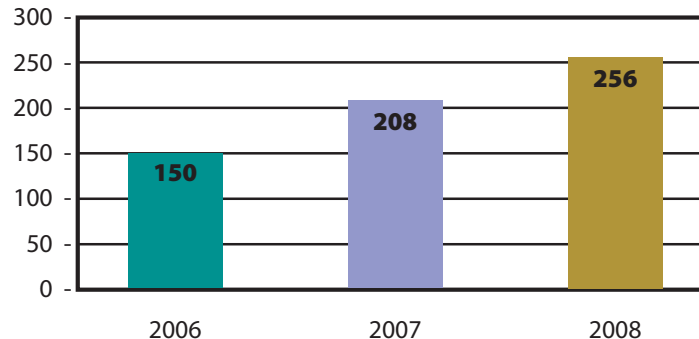
Impact 100 Was Founded On One Simple, But Powerful, Idea

Impact 100 Owensboro is a simple concept. We combine annual donations from a minimum of 100 members and give large grants each fall to local worthy causes selected by the members. The only membership requirements are to be female and to donate \$1,000 each year. All of the \$1,000 donations go to the grant. Separate funds are raised to cover fundraising and administrative costs.

In our first year, the women of Owensboro responded enthusiastically to the empowering opportunity of Impact 100. We achieved – and exceeded – our goal of 100 members. And now Impact 100 is growing.

After achieving our goal of over 100 women in our first year, 2006, our membership has grown each year. In 2007, we surpassed 200 members and were able to award two grants to deserving non-profits. 2008 was no exception as our membership grew even more and once again we were able to award two grants. In just 3 years Impact 100 has contributed \$614,000 to the Greater Owensboro area. Our goal is to reach \$1,000,000 in just five years!
