In 2001, a woman in Cincinnati, Ohio had an idea about how women joining together could change their community. She shared that idea with her friends, they shared it with theirs, and the idea eventually made its way to the western part of Kentucky- our Owensboro. Impact 100 was designed to remove the traditional barriers to giving and provide a unique experience to the donor. An experience so compelling, it would forever change lives. A significant grant (of at least \$100,000) means transformation for the grant recipient as well.

IMPACT 100 Owensboro was founded in 2005. Celebrating our Tenth Anniversary in October 2015, IMPACT 100 Owensboro has given a total of \$2,164,500 to worthy organizations to aid them in fulfilling their mission. By the end of 2015, Impact 100 organizations in the United States have given away more than \$33 MILLION to people in need. And it is still growing.

Girls Inc. "Impacting Safe Travels"

For 45 years Girls Inc. of Owensboro Daviess County has been dedicated to inspiring all girls to be strong, smart and bold.

Impacting Safe Travels replaced two vans with new vehicles to aid in the safe transportation to and from the club and on field trips for the 500 girls enrolled annually in Girls Inc. programming. It also allowed the implementation of the "Girls Under the Hood and In the Driver's Seat" programs to help girls and their mothers learn basic vehicle maintenance and safe driving techniques.



Lighthouse Recovery Services, Inc. "Safe Harbor Project"

Since its beginning in 2001, Lighthouse Recovery Services, Inc. has provided the opportunity for more than 640 participants to change their lives from substance abuse through safe housing, participation in a 12 step program, and effective mentoring. The Safe Harbor Project made much needed repairs, renovations, and upgrades to the facility on Hall Street to provide a more secure and functional residence for clients.

H. L. Neblett Community Center "Neblett Capital Improvement Projects"

Established in 1936, the H. L. Neblett Center remains committed to empowering the lives of children, older youth, adults and senior adults in the Owensboro and Daviess County area through a variety of services and activities including childcare, after-school enrichment, educational and recreational field trips, evening recreation programs and senior adult fellowship opportunities.

The Neblett Capital Improvement Project procured two transit vehicles to provide safe and efficient transportation and a new security system to assure a safe environment for the 4,000-plus community members who use the facility annually, the majority of whom are living at or below the poverty level.

Wendell Foster's Campus for Developmental Disabilities "Transportation for Community Involvement Project"

Founded in 1947, the Wendell Foster's Campus for Developmental Disabilities provides services to over 1,300 children and adults with disabilities ranging from autism to traumatic brain injury, muscular dystrophy, cerebral palsy and related disorders.

The Transportation for Community Involvement Project stemmed from the new federal regulations requiring many residents at the Wendell Foster's Campus to move from their current homes into scattered housing throughout the community. With the purchase of one cargo van, two used busses and a contractual agreement with GRITS, WFC has become a new Human Service Transportation Delivery provider – not only for the residents at the WFC, but for other individuals with intellectual and developmental disabilities living throughout the community.
